- Conduct regular staff meetings as need arises to address pertinent issues.
- Contribute to the writing of the Camp Mandala report.
- Foster a positive, inclusive camp culture that promotes personal growth, teamwork, and respect among campers and staff.
- Conduct evaluations of camp programs and staff performance at the end of each session, using insights to make informed decisions for future camp improvements and innovations.

- Minimum 3 seasons in outdoor education, camp management, or any related field is mandatory.
- Display Strong leadership skills (flexibility, a team builder, effective presentation skills, positive role modeling, sees the big picture/perceptive, is fair).

- Knowledge of relevant safety regulations and childcare standards is an asset.

Work environment.

The Camp Director will operate in a dynamic environment, often outdoors, surrounded by nature. Their workspace will not be confined to a traditional office; it will extend across the campgrounds, from cabins and activity areas to outdoor spaces where programs will be conducted. This role will require a hands-on approach to ensure the smooth operation of camp activities.

Work hours for a Camp Director will be irregular, with a schedule that stretches between 6am-8pm or on call for any emergencies beyond work hours.

You may also share a cabin and bathroom with another staff.
